Member acknowledges that the Releasees are not responsible for the condition of any playing field and/or equipment and releases and waives all claims against the Releasees for any injury, damage, or loss that may arise therefrom.

Member agrees that it is Member's personal responsibility to adhere to all rules and regulations and accept them as a participant in the SAN ANTONIO SSC.
